

## Terms and Conditions Governing the “Be our EZ-Link Champ” Lucky Draw (“Lucky Draw”)

1. These terms and conditions (“Terms and Conditions”) shall apply to the “Be our EZ-Link Champ” Lucky Draw (“Lucky Draw”) organized by EZ-Link Pte Ltd (“EZL”).
2. By registering or taking part in this Lucky Draw, you agree to be bound by these Terms and Conditions and the decision(s) of EZL in relation to and in connection with this Lucky Draw.
3. The Lucky Draw is for EZ-Link mobile app users who use EZ-Link CePAS and Account-based EZ-Link cards from 18th October 2021 to 17th January 2022 (both dates inclusive) (“Qualifying Period”) to pay for public transport rides (bus and rail).
4. To qualify for the Lucky Draw, you must fulfil all of the following criteria:
  - a. Download EZ-Link mobile app and link your EZ-Link CePAS or Account-based EZ-Link cards in the app; and
  - b. Use the linked EZ-Link CePAS and Account- based EZ-Link cards on your EZ-Link mobile app to pay for public transport rides (bus and rail) during the Qualifying Period.
5. You will automatically be enrolled and be entitled to a maximum of two (2) chances for the Lucky Draw:
  - a. One (1) chance awarded for every public transport (bus and rail) trip made with EZ-Link CePAS cards or
  - b. Two (2) chances awarded for every public transport (bus and rail) trip made with Account-based EZ-Link cards.
6. You will stand a chance to win the following prizes in the monthly draw. The draw dates will be on 30th November 2021 (Cycle 1), 30th December 2021 (Cycle 2), and 31st January 2022 (Cycle 3 and Grand Draw).
